## Feeling the benefit?

Make sure you claim any benefits you're entitled to, like Housing Benefit or help paying your Council Tax (check out <https://helpforhouseholds.campaign.gov.uk>). Please remember that if you are claiming these benefits, you must tell your benefit office about any change to your pension because it can affect your entitlement.

## Protecting your money
